PASTOR'S REPORT

³⁰you shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength.' ³¹The second is this, 'You shall love your neighbour as yourself.' There is no other commandment greater than these." Mark 12:30-31

We lived in Winnipeg from 1994 to 2002. We lived in a beautiful old neighbourhood, near the Assiniboine River, four houses from the primary dike. There was a great park and sledding hill near our house where we would go with the kids. And there was a railway bridge with a pedestrian walkway to Wellington Crescent, leading straight to Assiniboine Park.

Our small house was built in 1912. The main floor's support beam was exposed to the basement and we could see the watermark from the 1950's flood. The flood had filled the basements of the houses of the first part of our street, before the street sloped upward.

1997 saw the "Flood of the Century" with large parts of southern Manitoba covered by water. Unlike in 1950, the city of Winnipeg was now protected by a flood way that diverted water from the Red River around the city. However, no one knew how much water was coming our way and whether floodway and primary dikes would suffice. Every day on the evening news we saw the flood slowly moving north and there was nothing – save for sandbagging – anyone could do. Every day after work our whole neighbourhood met in the park to inspect that day's water levels and to provide moral support to one another.

I think of the experience of the Red River flood slowly moving north and being condemned to helplessly watching it come closer as I think of this past year. Perhaps it was in January that we heard first reports of this new virus, by February there were new cases, and not long after the Province issued the first health orders. Our service on March 22nd was our the first service we streamed as we knew that in-person gatherings created risks for our community and we knew that we had to find a way to continue in some way that resembled what we knew as normal.

My sincere thanks to Jordan Paterson who continues to stream our services and whose generous spirit and expertise has led to a steady improvement of the quality of audio and video. Thank you also to Doug Kobylanski whose work around sound and wiring continues to support our streaming. Among the platforms available we opted to live-stream on YouTube because

- it is most accessible (no account required, although a subscription offers benefits), including on Smart TV's for those who do not use computers,
- live streaming because it offers us the opportunity to gather at the same time. The pandemic has already upset our lives, and we thought it to be of benefit to maintain some of the normal rhythm of our lives by gathering at the usual time,
- live streaming allows for errors (like forgetting a prayer, mispronouncing a word) which makes it more like our normal Sunday experience,
- while live-streaming requires expertise, equipment, set-up and take-down, it requires no editing and thus is more efficient.

We are using Zoom for meetings, coffee hour, Readers, and studies. Zoom is simple to use, can be used with landline phones, cell phones, tablets, or computers and allows us to interact with each other.

Holy Communion: At the very beginning of the pandemic we moved to serving communion in only one kind (bread) and then suspended our celebration. While some congregations are celebrating communion online with the pastor asking worshippers at the beginning of the service to have bread and wine ready, I have chosen to suspend the celebration of the Eucharist for our streamed services. I have done so because the body of Christ that we receive requires the church as the body of Christ to gather. Christ becomes embodied in the sacrament but also becomes embodied in us, not only as individuals but as the church.

I have also done so because I firmly believe that not even a pandemic and a sacramental fast can separate us from the love of God in Christ Jesus.

That being said it has been a joy to celebrate Holy Communion during our outdoor parking lot services and I look forward to the first warm days of spring as well as to gathering again once the vaccination program is complete.

I am profoundly grateful to our musicians who have not only offered their gifts as they always do, but have worked to compensate for the lack of in-person worship with different arrangements, more instrumentation (piano, organ, bells, viola), and fantastic availability whether it was their month or not. They were also available to pre-record services for the Sundays we were meeting in our parking lot, so no one was left without the ability to participate in our services. Alex has been here every single Sunday save one to lead our congregational singing and coordinate and offer music meditations. Of course, for every recording Jordan has also been here. My sincere thanks also to all other musicians and singers in the congregation who participated in our services: Duncan, Carrie S, Dale, Dianne, Elise, Ellen, Joshua. Your gifts and participation greatly add to our celebration of worship.

There are three things that guided my thinking regarding our response to the pandemic. The first one was to ensure the greatest amount of safety for everyone. The second one was to not allow the pandemic change the pattern of our lives regarding worship and to prevent the pandemic from instilling fear in us (as opposed to care and caution). The third one was for worship, studies, coffee time, phone tree, and general contact between us to keep us together, to maintain our sense of identity as a congregation, as God's people. I am thankful for your ongoing participation, support, and love and care for each other.

In 1933, the same year that Hitler became chancellor of Germany, the theologian Karl Barth declared as his motto "to do theology and nothing but theology." Although his statement has sometimes been misunderstood, what Barth meant was that theology would judge history and not the other way around. Consequently, Barth was the leading theologian in the writing of the Barmen Declaration, the Confessing Church's rejection of Nazi interference and ideology in 1934.

In a similar but much less dramatic way it was important for us to continue to worship without interruption, despite the occasional technical challenges. And to carry on is a statement of faith, expressed here in the words of Psalm 62: "5For God alone my soul waits in silence, for my hope is from him. 6He alone is my rock and my salvation, my fortress; I shall not be shaken."

All this does not mean that the pandemic has not been a significant challenge, not only to the church but to people everywhere. Recognizing the hardship and grief some have to bear has helped us put the suspension of in-person gatherings into perspective. We are not suffering in the same way. And this isn't for forever.

I am deeply thankful to church council and our worship committee for their work and guidance in this time, in addition to their regular duties. None of them expected a year like this. And I am thankful for the work of all of our committees.

I am thankful for all volunteers who carried on with lawn and yard care, altar care, counting, reading, gift card purchasing, taking the recycling home and whatever else there is that I missed.

Dianne continues to be an invaluable resource to church and daycare, and also to me. There have been many times during the pandemic when I was trying to solve some kind of problem and I would turn to Dianne and say, "Here's my idea, what do you think?"

You will read in the financial report about our rental revenue during the last year. All I want to say here is that we have excellent relationships with our tenants and are particularly grateful for our relationship with Richmond Gospel Baptist Church.

This has been a difficult year also for our family. We are so grateful we were still able to have a funeral service for our beloved boy, and we remain grateful for your love and your prayers.

I want to finish my report with these verses from Psalm 91:

¹You who live in the shelter of the Most High, who abide in the shadow of the Almighty, ²will say to the Lord, "My refuge and my fortress; my God, in whom I trust." ³For he will deliver you from the snare of the fowler and from the deadly pestilence; ⁴he will cover you with his pinions, and under his wings you will find refuge; his faithfulness is a shield and buckler. ⁵You will not fear the terror of the night, or the arrow that flies by day ...

In spite of everything this year has brought, we know that we are held in God's love. For that we give thanks.

I suggested that due to the massive disruption in everyone's lives that we try our best to stream our own OSLC Easter service with Pastor leading, so at least we can all have a sense of normalcy on that day. I am glad that Pastor agreed and we have not looked back since!

A huge thanks and blessings to Jordan Paterson and Doug Kobylanski for taking the lead in getting our streaming service up and running and sticking with it through all the headaches and technical problems. Thanks so much to Alex Gowans for always being at service and providing the music along with Bev and Calla and Marion for always being there. And of course, thank you to Dianne Jager for continuing to do her work in such a professional manner which enables the administrative tasks, bookkeeping and the 'day-to-day' running of the church and Daycare to be completed smoothly in these times.

Thanks to Carrie, Calla, Marion, Alissa, Ed, and Jackie for keeping the Daycare strong and moving forward. We are in a much better place now with the daycare than we were two years ago. Thanks to all those who continue to serve on our various committees and keeping our church functioning.

And of course without the guidance and leadership of Pr. Christoph we would not be as strong as we are today and we continue to lean on him for stability and keeping us strong and grounded. We are blessed and thankful to have you Pastor and thanks for all you do and for our conversations.

Covid restrictions unfortunately affected our revenue streams from other sources. Luminix had to refrain from starting their home schooling classes but we are confident that they will be back when this is over and we continue to maintain our communications. We also are thankful for our continued healthy relationship with the Richmond Gospel Baptist Church. Although they are not using our building they continue to pay a portion of their rent and we are extremely blessed for that and Pastor is in touch with them regularly and they will be back as well when this is over.

We all know the financial hardships the pandemic has caused and OSLC is not exempt. We are however in a much better position than anticipated thanks to each of you and Chris Stocco for finding ways to ease the financial burdens. We are deeply blessed to have our members step up where possible and I encourage you to keep asking for financial updates and council is committed to providing one each quarter.

Ongoing regular maintenance was the priority for 2020 and there were no major projects completed. We did however purchase hardware and software to enable us to provide the streaming service and we continue to upgrade both in order to maintain quality.

I want to end by saying this year will continue to be extremely challenging for obvious reasons but we will get over this with the help of God and we are all praying for this to be over sooner than later. Council and Pastor Christoph will continue to provide the leadership and it's my hope that you will all keep in touch and watch the online services. We will all be together again soon.

Worship Attendance for 2020

This year there is really no way to calculate attendance. We can see that we have between 60 to 80 views each Sunday (from different IP address') and there are people viewing/following Our Saviour services from other parts of the country (talk about outreach!) We had an average of 30 people attending our "in person, parking lot services".

CHILDCARE CENTRE REPORT

The Board of Our Saviour Lutheran Childcare Ltd. presents its annual report to the congregation of Our Saviour for the year 2020.

As with everything else, the daycare did present new challenges with COVID. Surprisingly though, financially, it weathered these quite well. The one thing we have finally gotten through is our staff issues. We have such an amazing team of dedicated staff who love the children and want to work together. Thank you to Andrea, Cindy, Spencer, Behi and Jennifer.

The daycare was closed for only one day in March with COVID but four of the staff were temporarily layed off. By May we were slowly able to get things up and running again. The staff determined that they didn't want to open the doors to essential workers so that the children would not be exposed further. Many parents did keep their children at home. As the months passed, more families returned to the center and were able to bring back the remaining staff to work.

The daycare was able to take advantage of several of the government sponsored COVID benefits. We qualified for the \$40,000 Canadian emergency business account which is an interest free, payment fee loan. If \$30,000 of the amount is repaid by December 31, 2022, the remaining \$10K is forgiven.

We also qualified for the temporary wage subsidy of 10% of salaries for the months March – June and finally the Canadian emergency wage subsidy for several months. These subsidies and programs allowed us to keep our staff working and truly subsidized our operating costs for the year.

Currently we have 18 children at the center and things are going well. This is just over half what we are licensed for. We have 2 additional children enrolled but parents have continued to keep them home due to COVID. Andrea is expecting them to return by March 2021. We also have 2 other children confirmed to start in April. Andrea has been having several tours with families so hopefully we will be able to fill our remaining places this year. Our licensing reviews are also back on track with generally minor improvements required i.e., we had to replace the sleeping mats for the children.

For 2020, the Child Care Centre paid rent of the full budgeted amount of \$40,000 to the church, as well as it contributed \$6,500 towards the joint church and daycare insurance bill and made a year end donation of \$10,000 for a total of \$56,500. This is up from \$27,000 in 2019 so truly blessed.

Thank you, daycare board members once again for all your time and dedication on the daycare operations.

TREASURER'S REPORT

The Treasurer's report covers the financial results for Our Saviour Lutheran Church (the "Church") for 2020 as well as the proposed budget for 2021 which will be considered for approval by the congregation at the Annual General Meeting to be held on February 28, 2021. Please refer to the attached schedule, Exhibit A and the included schedule, Exhibit B, which set out the financial position of the Church as at December 31, 2020, as well as the 2021 proposed budget.

2020 Results

The table below summarizes the financial results for the Church between 2010 and 2020.

Revenue

Congregational regular giving of \$119,108 was \$4,108 higher than the budget of \$115,000. The Special Appeal raised \$11,426 which was \$20,574 short of our goal. If we combine Congregation regular giving and the Special Appeal, we were \$16,466 short of our goal.

Rental income was \$25,300 lower than budget as of the result of RGBC and Luminix Education not using our space beginning in April 2020. The Daycare was able to meet its budgeted rent as a result of receipt of \$42,522 from government COVID relief programs.

Loose offering was \$1,109 lower than budget as a result of provincial health orders restricting inperson services.

The Church's revenue was bolstered by the following:

- Payments from government COVID relief programs totaling \$15,455;
- A gift from the BC Synod of \$10,000; and
- A donation from the Daycare of \$10,000.

Personnel expenses

Personnel expenses were \$9,042 lower than budget. This positive variance was a result of several factors; however, most of the positive variance was a result of our Office Administrator's medical leave that was reimbursed by health insurance.

Council elected to pay the Choir Director's fees for the months of July and August which are historically not budgeted due to vacations. The payment in 2020 was made to recognize Alex Gowan's amazing contributions to the parking lot services in the summer and the online services throughout the year.

Administration and operating expenses

Administration and operating expenses were \$11,133 less than budget. There were many items that contributed to the positive variance as Council continues to keep operating expenses to a minimum. A notable variance was repairs and maintenance costs (regular and capital) which were \$3,435 less than budget as discussed below.

Repairs and maintenance

In 2020, \$21,565 was spent on all repair and maintenance items which we classify into two categories:

- 1. Regular repairs and maintenance to maintain the Church; and
- 2. Capital repairs and maintenance which includes items that are larger and more expensive in nature that are not commonly repaired or replaced every year.

Regular repairs and maintenance were \$7,487 higher than in 2019, and were \$1,686 higher than the budget of \$15,000 in part due to Daycare washroom plumbing repairs, much needed maintenance to lighting around the Church and the Daycare, the replacement of the plexiglass on the road sign and expenses to comply with the local fire code set up on the annual fire inspection.

Capital repairs and maintenance was \$5,121 less than the budget of \$10,000. The only capital project that was undertaken during the year was the Daycare washroom renovations.

Overall operating results

Overall, the Church had an operating gain of \$12,767. Without the \$35,455 received from government relief programs, donations and gifts, the Church would have incurred an operating loss of approximately \$22,688.

Statement of Financial Position

Cash on hand as at December 31, 2020 was \$11,581. This represents our accounting "book balance" which includes all outstanding cheques as at December 31, 2020. The actual bank balance was \$25,822 on December 31, 2020, which was approximately \$6,000 more than December 31, 2019. As at December 31, 2020 there was approximately \$14,000 in outstanding cheques.

We required the use of our line of credit between February 5, 2020 and October 30, 2020. The highest utilization of the line of credit was \$27,383 on September 5, 2020.

Designated Funds of \$25,649 as at December 31, 2020 include the following:

- Memorial \$5,470:
- Refugee \$10,894;
- Christmas Hampers \$3,226;
- Social Ministry \$1,864;
- Sunday School \$417; and
- Youth \$452.

Accounts receivable of \$2,536 relates to December 2020's COVID wage relief payment that was received on January 12, 2021.

Other liabilities which total \$183 relate to WCB premiums payable in March 2021.

The GST Receivable of \$997 should be received in February 2021.

Based on the current cash position, the Church would have to borrow from the line of credit with Coast Capital Savings if decided to spend the Designated Funds as we do not have cash on hand to cover all of these amounts.

2021 Budget

Revenue

The 2021 budget includes total revenues of \$164,960 which is \$57,532 less than the actual revenue in 2020 including government COVID relief programs, donations, gifts and the Special Appeal.

Congregational general giving is budgeted at \$120,000 which is approximately the amount received in general offering in 2020. Council has not budgeted any amounts towards government COVID relief programs, donations and gifts due to the uncertainty of these items. Further, Council has not included any amounts towards the Special Appeal as this was initially introduced as a temporary measure to support the rebuilding of the Daycare during its financial troubles which have now stabilized. If, after reviewing the 2021 budget, members are of the view that the Special Appeal is required to bridge the continued reduction of rental income (discussed below), a motion for a Special Appeal may be made at the Annual General Meeting.

The Daycare's Facility Fee remains unchanged from 2020 at \$40,000.

RGBC has agreed to pay \$100 per week to help with operating costs. We have assumed for budgeting purposes that like us, RGBC will be unable to hold in-person services in 2021. Total budgeted revenue from RGBC is \$4,800 which is \$1,600 less than they paid in 2020. We are grateful for their contribution.

In the fall of 2019, we agreed to rent out the upper classroom space to Luminix which is a group of local parents that are using the space to home school approximately nine children. Luminix did not use the space after March 2020. Luminix has advised that they continue to have interest in using the space once it is safe to hold in-person instruction. For budgeting purposes, we have not included any revenue from Luminix in the 2021 budget.

Expenses

Total expenses are budgeted to be \$10,151 higher than 2020's actual expenses.

Personnel expenses

Personnel expenses are \$7,860 higher than the actual for 2020 as we are budgeting to pay the Office Administrator and the Choir Director's wages for the full year. We have not budgeted any increases to the Pastor's salary, the Office Administrator's wages or the Organist and Choir Director's rates in 2021.

Administration and operating expenses

The amount budgeted for administration and operating expenses is \$6,356 more than 2020 actual expenses. The main items to note are:

- We have budgeted for the purchase of a new Sunday School curriculum for the fall;
- Insurance premiums have increased \$700 over 2020. The Daycare is budgeting to reimburse the Church \$6,500 of the total insurance cost in 2021 which is reflected in the budget; and
- We have increased the Office Expenses, Telephone & Internet, Utilities and Municipal Charges and Worship supplies to historical usages.

Regular repairs and maintenance expenses have been budgeted at \$17,500 which is in line with recent historical spending particularly in years with heavy snow removal costs; and

We have not budgeted any capital repairs and maintenance items for 2021 due to the financial pressures and minimal use of the Church aside from the Daycare.

Cash Position

At the end of 2021, we are budgeting to utilize \$46,561 of our line of credit with Coast Capital Savings. The line of credit has a \$100,000 limit and an interest rate of prime.

2021 Budget Summary

It has been the most challenging year for the congregation. By the grace of GOD and with the support of government relief programs, a gift from the BC Synod and a Daycare donation, we were able to improve our financial position over 2019. With the prospects of another 9 to 12 months of COVID related restrictions, our 2021 budget is indicating that our financial position will deteriorate over the course of the year; however, if restrictions are lifted in late summer or fall, we may see an improvement over the budget. We respectfully ask members to carefully review the 2020 financial results and the 2021 budget on the following pages. After some prayerful consideration of our call to stewardship, we hope that you will provide Council with guidance at the Annual General Meeting.
